From the Directive 2004/38/EC, Article 5.2 (Right of Entry relating to non EEA Family members),

" 2) Family members who are not nationals of a Member State shall only be required to have an entry visa in accordance with Regulation (EC) No. 539/2001 or, where appropriate, with national law. For the purposes of this Directive, possession of the valid residence card referred to in Article 10 shall exempt such family members from the visa requirement.

Member States shall grant such persons every facility to obtain the necessary visas. Such visas shall be issued free of charge as soon as possible and on the basis of an accelerated procedure."
